Include a report on the progress the PHA has made in meeting the goals and objectives described in the previous 5-Year Plan.</p> <p>GOAL I: PLAN FOR FUTURE GROWTH OF MHA The Manhattan Housing Authority has completed capital improvement projects as feasible, and completed an Energy Performance Contract to add energy efficiency to all units.</p> <p>GOAL II: INCREASE AFFORDABLE HOUSING IN THE COMMUNITY THROUGH SECTION 8 RENTAL ASSISTANCE: The total number of landlords has fluctuated with the leasing of additional units and program terminations (voluntary and involuntary). The Manhattan Housing Authority encouraged landlord participation through speaking engagements and the local Fair Housing Seminar.</p> <p>GOAL III: PARTNERSHIPS WITH OTHER SOCIAL SERVICE AGENCIES IN THE COMMUNITY; Though no new formal partnership agreements have been established, informal partnerships have increased through referrals and mutual participation in community groups. Many resident and applicant referrals have been made to other agencies for shelter, food, additional services needed to remain independent, rental assistance, etc.</p> <p>GOAL IV: REMEDIATE ENVIRONMENTAL CONCERNS AT THE APARTMENT TOWERS The mold remediation and reconstruction was completed in September 2018. The Energy Performance Contract was substantially completed in March 2017.</p> <p>GOAL V: SALARY STUDY A formal salary study was not completed; however, the Salary Administration Plan was updated to ensure that the salary scale is revised at the same time COLA increases are approved to ensure that the salaries remain current with cost of living adjustments.</p> <p>GOAL VI: INCREASE RESIDENT ASSOCIATIONS / RESIDENT AWARENESS Efforts to increase resident participation through Resident Associations and Neighborhood Watch have been unsuccessful. Some residents express interest in participating, however do not follow-through with the activities required to form associations, etc. There has been a large turnover in residents, which has also impacted continuity of interest.</p> <p>GOAL VII: INCREASE VISIBILITY IN THE COMMUNITY The Manhattan Housing Authority has increased its efforts to raise awareness of our programs and services in the community through print media, local radio shows, speaking engagements, etc. with emphasis on the availability of units at the newly renovated Apartment Towers. Various flyers have been created to provide to agencies for placement in their program materials as a resource for affordable housing.</p>

The Section 8 HCV program provides a preference for victims of domestic violence, dating violence, sexual assault and stalking. The MHA also strives to support domestic violence programs through case management with the Crisis Center, Inc and outreach to residents who are potential victims of domestic violence.</p> <p>The MHA will continue to review cases of possible domestic violence to ensure the applicants and participants are not denied based upon incidents in which they are victims of domestic violence, dating violence, sexual assault and stalking; train staff on changes to VAWA and local policies and procedures; provide applicants and participants with information concerning their rights under VAWA; expedite requests for VAWA emergency transfers; and update VAWA related policies and forms to reflect changes in Federal, State and/or local law as necessary.</p> <p>All applicants for Section 8 HCV and Public Housing are advised of their rights under VAWA at the time of application and again at the time of admission to any program, and existing program participants are advised of any policy changes as they occur. Section 8 HCV Landlords are also informed of the VAWA requirements at the time they become a Section 8 HCV Landlord and also of any policy changes that affect them.</p> <p>All program participants sign a VAWA Lease Addendum at the time of admission to the program. Each adult member of the household is required to sign.</p>

The PHA will affirmatively further fair housing by examining their programs or proposed programs, identifying any impediments to fair housing choice within those programs, addressing those impediments in a reasonable fashion in view of the resources available and work with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement and by maintaining records reflecting these analyses and actions.
 8. For a PHA Plan that includes a policy for site based waiting lists:
 - The PHA regularly submits required data to HUD's 50058 PIC/IMS Module in an accurate, complete and timely manner (as specified in PIH Notice 2010-25);

- The system of site-based waiting lists provides for full disclosure to each applicant in the selection of the development in which to reside, including basic information about available sites; and an estimate of the period of time the applicant would likely have to wait to be admitted to units of different sizes and types at each site;
 - Adoption of site-based waiting lists would not violate any court order or settlement agreement or be inconsistent with a pending complaint brought by HUD;
 - The PHA shall take reasonable measures to assure that such waiting list is consistent with affirmatively furthering fair housing;
 - The PHA provides for review of its site-based waiting list policy to determine if it is consistent with civil rights laws and certifications, as specified in 24 CFR part 903.7(c)(1).
9. The PHA will comply with the prohibitions against discrimination on the basis of age pursuant to the Age Discrimination Act of 1975.
 10. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped.
 11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
 12. The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.
 13. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
 14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
 15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
 16. The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
 17. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
 18. The PHA will comply with the policies, guidelines, and requirements of OMB Circular No. A-87 (Cost Principles for State, Local and Indian Tribal Governments), 2 CFR Part 225, and 24 CFR Part 85 (Administrative Requirements for Grants and Cooperative Agreements to State, Local and Federally Recognized Indian Tribal Governments).
 19. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
 20. All attachments to the Plan have been and will continue to be available at all times and all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary business office of the PHA.
 21. The PHA certifies that it is in compliance with applicable Federal statutory and regulatory requirements, including the Declaration of Trust(s).
